

Further, in terms of the Joint Development Agreement dated 14/12/2012 and the Supplementary Agreement cum Rectification Deed, with M/s. Monarch, the OwnersDr. (Smt.) B. M. Nirmala, Sri. V. O. Kiran, Ms. V. P. Padmashri, are collectively entitled to 22.26% of the total super built area in the residential developments, together with proportionate share of car parking
